Memorandum of Understanding Between

### ARTICLE 1: RESPONSIBILITIES OF EACH PARTY

### A) Roles and Responsibilities of Ms. Rashmi Joshi:

- 1. Conduct awareness sessions as well as activities amongst youth and students about the use of waste and water as resource and its relationship with climate change and global warming. {Promote knowledge and provide training for segregation at source and composting, among students, faculty and non-teaching staff.}
- 2. Encourage and promote environment related activities such as composting of canteen and garden waste, Organic Farming, Energy Conservation, Waste Management for Better Tomorrow, Plastic Waste Management, Green Initiatives for Healthy Life, Ewaste Awareness and Collection Drives, Seed-balls Making, and Rainwater Harvesting.
- 3. Sensitize and involve students from the college for promoting the concept of the environment related projects.
- 4. Conduct various environmental competitions for the students.

# B) Roles and Responsibilities of College

- 1. The college will make arrangements for the awareness lectures.
- The students and teaching staff will actively participate in the recycling of the waste
- 3. Environment projects are a part of college environmental activity and hence it will be monitored on a regular basis by DLLE /Nature Club / NSS students and faculty
- 4. College will nominate a contact person to who will submit annual activity report at the

## ARTICLE 2: DURATION AND EVALUATION

- This MOU shall be in effect for a period of 5 years from 6th February, 2023 2.1 to 6th February ,2028. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date. Termination of this MOU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.
- A joint evaluation of the MOU will be initiated by the designated 2.2 representatives six (6) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.
- Amendments to this MOU may be requested, in writing, by either party 2.3 and approved by the authorized signatories.
- The parties to this MOU undertake to treat as CONFIDENTIAL AND 2.4 PRIVILEGED information of the other party, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- This MOU shall require the ratification of the competent academic / 2.5 executive body of both the parties.
