- 2.4 The First Party will acknowledge the source and ownership of the online courses and course materials in any publication or presentation that uses or refers to them.
- 2.5 The First Party will provide feedback and suggestions to the Second Party on the

quality, relevance and effectiveness of the online courses and course materials.

DISPUTE RESOLUTION

- 4.1 Any dispute arising out of or in connection with this MOU shall be settled amicably by mutual consultation and negotiation between the parties.
- 4.2 If the dispute cannot be resolved by mutual consultation and negotiation within 30 days, then the parties shall refer the dispute to arbitration by a sole arbitrator appointed by mutual consent of both parties. The arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof. The arbitration shall be held in Mumbai, Maharashtra, India and the language of arbitration shall be English. The award of the arbitrator shall be final and binding on both parties.
